Hall Improvements:

- Entrance: Scott reached out to Fynboh Construction about getting the entryway concrete poured. Pads would be poured at each entrance. Scott has not received a response on the cost or time estimate.
- Tables: Bob is looking into tables, no rental until October
- Flag: Scott will look into ordering a flag on a stand
- Map: Currently being framed at 509 Gallery - \$100 payment down
- Water Softener – Bob mentioned potential to purchase a water softener, would protect investment of new plumbing.
- Sign: Bob said it would be nice to get a sign for the hall.
- Website: Kristen got a quote to update the hall website. The quote was for \$500. The Board believes this is a good investment so residents can self-serve for permits, minutes, and other data. Jerod made a motion to updated the website, Bob seconded.
- Computer: Bob made a motion to approve a new computer purchase for John Kotaska's computer, Jerod seconded. This would be covered by ARPA funds
